

# General Terms and Conditions

## Introduction

1. By entering the Corian® Design Award Promotion, 2017, you agree to be bound by these Terms and Conditions of the Promotion and any instructions relating to the Promotion as outlined on the CASF Website.
2. CASF may in its absolute discretion refuse to award any Prize to any entrant who fails to comply with these Terms and Conditions.

## Promotion Period

3. The Promotion commences 1st January 2017 and concludes 22nd December 2017. Any entries received after the expiry of the Promotion Period will be deemed invalid. No responsibility is accepted for late, lost, delayed or misdirected entries.

## Entry Criteria

4. An entrant of the Promotion must be a Specifier, Architect/Designer or Design Student and must have included Corian® Solid Surface material as part of their project design. All entries can be done online via the [www.casf.com.au](http://www.casf.com.au) website.
5. Entrants can enter the Promotion throughout 2017. At the end of each quarter (March, June, September and December) two entries will be announced and shortlisted to go into the final pool of candidates, whereby an overall winner will be selected in January 2018.
6. All images must be supplied as high resolution (300pdi or greater).

By entering, you assert the truthfulness of this information and assign copyright of your entry text and images to CASF Australia, further authorising the editing and publication of the project statement by CASF Australia and its partners on the CASF website and in any associated promotional materials, without limitation.
10. All entrants must obtain permission from the commissioning client to enter the project into the awards.
11. Any entries that are subsequently found to breach any of the terms and conditions of entry will be ruled invalid and withdrawn from consideration for the Promotion.

15. The overall winner will be selected by an independent judging panel assembled by CASF. The overall winner will be selected and announced in January 2018.
16. All judges' decisions are final and no correspondence will be entered into relating to the judging process or the outcome.

## Prize

17. The Prize is FREE economy flights for 2 people from any capital city within Australia and twin share accommodation in or near Milan (the package) to attend the Milan Design week in April 2018.
18. Reasonable notice of the departure date will be given to the Prize winner.

## Prize Restrictions

19. CASF will not be responsible for any additional costs associated with the Prize. The Prize winner (and, if applicable, their guest) is responsible for all incidental costs associated with the Prize including (if applicable) travel and/or transfer costs, expenses with respect to food and beverages, travel and medical insurance costs and spending money.
